described Equipment. The certificate of insurance will indicate that User has made Equipment Owner an "additional insured" on User's policy with respect to the use of the Equipment.

Property Insurance. User promises and warrants that User will keep the equipment insured against all risks of loss or damage from every cause whatsoever for full replacement value of the Equipment and name Equipment Owner as a loss payee.

User agrees to hold harmless, indemnify and defend Equipment Owner (including Equipment Owner's agents, employees, and representatives) from any and all liability for injury or damage including, but not limited to, bodily injury, personal injury, emotional injury, property damage, or financial damage, which may result from any person using the equipment while the equipment is in the care of User, regardless of whether such injury or damage results from the negligence of the Equipment Owner (including equipment owner's agents, employees and representatives) or otherwise.

Equipment Owner, being neither the manufacturer, nor a supplier, nor a dealer in the equipment, makes no warranties, express or implied, as to any matter whatsoever, including, without limitation, the condition of the equipment, its merchantability, its design, its capacity, its performance, its material, its workmanship, its fitness for any particular purpose, or that it will meet the requirements of any laws, rules, specifications, or contracts which provide for specific apparatus or special methods. User accepts the equipment "AS IS."

User agrees that Equipment Owner will not be responsible for any failure of equipment for any reason.

This agreement may be cancelled unilaterally by either party with 14 days written notice to the other party. In no event will Equipment Owner be liable to User for any lost profits or incidental, indirect, special, or consequential damages arising out of User's inability to use the Equipment, even if Equipment Owner has been advised of the possibility of such damages.

User has inspected the Equipment and acknowledges that the Equipment is in good and acceptable condition.

User agrees not to assign any of its rights under this agreement, and any such assignment will void this agreement at the sole option of the Equipment Owner.
